### **EXECUTED BUY-BACK PROGRAM**

**Luxembourg - October 02<sup>nd</sup>, 2015** – In accordance with the authorization issued by the Shareholders' meeting of 29 March 2011 and following the Board of Directors resolution of 5 July 2011, d'Amico International Shipping S.A. - as provided by the Consob Resolution n. 16839 of 19 March 2009 and of article 4.4, therein recalled, of the Commission Regulation (CE) n.2273/2003 of 22 December 2003 - hereby discloses that during the period between September 25<sup>th</sup> and October 01<sup>st</sup> 2015, repurchased, on the regulated market managed by Borsa Italiana S.p.A., nr. 20,000 own shares, representing the 0.00473% of the outstanding share capital of the Company, at the average price of Euro 0.7083, for a total consideration of Euro 14,166. As at October 01<sup>st</sup> 2015, d'Amico International Shipping S.A. holds nr. 5,826,164 own shares, representing the 1.3779 % of the outstanding share capital.
