### **d'AMICO INTERNATIONAL SHIPPING S.A. ANNOUNCES THE POSTPONEMENT OF THE DELIVERY OF THE M/T FABRIZIA D'AMATO**

**Luxembourg – August 02<sup>nd</sup>, 2011** – d'Amico International Shipping S.A. (Borsa Italiana: DIS), a leading international marine transportation company operating in the product tanker market announces that, following the request of the current owner, D'Amato Shipping S.r.l., agreed to postpone to October 2011 the delivery of the handy-size M/T Fabrizia D'Amato, a 40,081 dwt. double-hulled product chemical tanker Vessel built in 2004 by Shin-A Shipbuilding Co. Ltd. shipyard, South Korea, whose purchase was announced on May 5<sup>th</sup>, 2011. The due date by which the judge should take the decision closing the procedure ('concordato preventivo') has been again postponed to September 15<sup>th</sup>, 2011 (ref. press release July 11<sup>th</sup>, 2011). The purchase of M/T Fabrizia D'Amato is subject to that decision.

As of today the operational fleet of d'Amico International Shipping S.A. includes a total of 37 double-hulled medium range (MR) and handysize product tankers, with an average age of about 5 years. Following the acquisition of the M/T High Century, it comprises of 20 owned vessels and 17 chartered-in vessels.

The company's shares are listed on the Milan Stock Exchange under the ticker symbol "DIS".*
