EXECUTED BUY-BACK PROGRAM

Luxembourg - December 01st, 2020 – d’Amico International Shipping S.A. (following “DIS” or the “Company”) announces today that during the period between November 23rd and November 30th 2020, n. 1,377,189 own shares (representing 0.111% of the outstanding share capital of the Company) were repurchased on the regulated market managed by Borsa Italiana S.p.A. at the average price of Euro 0.0964 and for a total consideration of Euro 132,711.58.

As at December 01st, 2020, d’Amico International Shipping S.A. holds nr. 11,519,216 own shares, representing 0.93% of its outstanding share capital.

The transactions were made and coordinated by an independent equity broker duly engaged for this purpose, Equita SIM S.p.A., in compliance with the Board of Directors resolution of 13th of November 2019 and under the authorization to purchase own shares approved by DIS Shareholders' Meeting on 20th April 2016 (as reminded by means of a press release issued on 13th November 2019).
