



## **PRESS RELEASE**

### **EXECUTED BUY-BACK PROGRAM**

**Luxembourg - December 2<sup>nd</sup>, 2024** – d'Amico International Shipping S.A. (following “DIS” or the “Company”) announces today that during the period between November 27<sup>th</sup> and November 29<sup>th</sup>, 2024, n. 113,479 own shares (representing 0.091% of the outstanding share capital of the Company) were repurchased on the regulated market managed by Borsa Italiana S.p.A. at the average price of Euro 4.0579 and for a total consideration of Euro 460,485.20.

As at November 29<sup>th</sup>, 2024, d'Amico International Shipping S.A. holds nr. 4,896,732 own shares, representing 3.95% of its outstanding share capital.

The transactions were made and coordinated by an independent equity broker duly engaged for this purpose, Equita SIM S.p.A., in compliance with the Board of Directors resolution of June 14<sup>th</sup>, 2023, and under the authorization to purchase own shares approved by DIS Shareholders' extraordinary meeting held on June 13<sup>th</sup>, 2023 (as reminded by means of a press release issued on June 14<sup>th</sup>, 2023).
